

Certificate for manufacturing and selling of compostable plastic bags and commodities in Indian market is hereby issued to M/s Shakthicups plant located at S.F. No. 1321/1 to 7 Part, Erode Village, D. No. 54 Kalyanasundaram Street, Vendipalayam, Erode Taluk, Erode District -638002 as "MANUFACTURER" with the following conditions:

- The end product \*Compostable plastic and commodities \* shall be manufactured using the raw materials "PLA, PBAT" and following the production process (Annexure I).
- Each carrybag and commodities made from compostable material or plastic shall bear a label "COMPOSTABLE" IS/ISO:17088 titled as Specifications for "Compostable Plastic" in English & regional language. Each carrybag and commodities shall also have printed code and Certificate Number of "MANUFACTURER"
- The manufacturer shall generate QR code based on the details (Name, plant address, CPCB certificate no. etc.) provided in the certificate issued by CPCB and QR code shall be provided on each of the carry bag and commodities manufactured at the certified unit. The "verifiable" details of the QR code shall be shared with the SPCB/PCC/CPCB within one month of issue of this Certificate
- This certificate issued by CPCB shall not require renewal. However, a fresh application shall be filed with CPCB for grant of certificate, in case there is any change in raw material/ production process or product.
- The Manufacturer shall provide six-monthly report giving details of raw material procurement and product sale to SPCB/PCC/CPCB as per the prescribed format.

- The unit shall adhere with all the conditions mentioned in the Plastic Waste Management Rules, 2016 as amended in 2018.
- The unit shall ensure that multilayered packaging shall have name and Registration number of the Manufacturer.
- The unit shall ensure that each compostable plastic carry bag shall have name, registra number of the manufacturer and thickness of each bag and also certificate number obtain from CPCB.
- Each carry bag made from compostable plastics shall have a label "compostable" and shall conform to the Indian Standard: IS or ISO 17088:2008 title as specifications for "Compostable Plastics".
- "Compostable Plasties".

The unit shall ensure that plastic sheet or like/cover made of plastic sheet shall have the name of the manufacturer, registration number of the manufacturer, thickness of plastic sheet/cover and usage purpose of the plastic sheet/cover made of plastic sheet or like/cover made of plastic sheet used for packaging, wrapping the commodity shall not be less than fifty microns in thickness except where the thickness of such plastic sheets impair the functionality of the product.

- The unit shall provide QR code/bar coding for the compostable carry bags manufactured by them in order to prevent fake compostable carry bags.
- The unit shall coordinate with UNDP to workout EPR inline with the proposed integrated model for the state of TN.
- The Producer shall submit action plan for waste collection system based on EPR enclosed by the MAWS Dept at the time of recovery of Registration.
- The unit shall furnish their production, distribution and retailer/sale point details every
  month to the District Environmental Engineer citing the Registration Number.

#### Additional conditions

- 1. The unit shall ensure each plastic carry bag and multi-layered packaging shall have the information related to name and certificate number of manufacturer [Rule 4(h)] in case of carry bags made from compostable plastic printed in English on the bag in accordance with 11(1) of Plastic Waste Management Rules.

  2. The unit shall ensure that the manufacturer shall generate QR Code based on the details provided in
- Management Rules.

  2. The unit shall ensure that the manufacturer shall generate QR Code based on the details provided in the certificate issued by CPCB and QR Code shall be provided on each of the carry bag manufactured at the certificat unit and the details of the QR Code shall be submitted to the Board.

  3. The unit shall ensure that the manufacturer/seller shall provide six monthly report giving details of raw material procurement and product sale to the Board.

  4. The unit shall adhere to Plastic Waste Management Rules, 2016 as amended at all times.

  5. The unit shall comply with the directions issued by the Hon'ble NGT (PB) in O. A. No. 593 of 2017 at all times.
